The workshops will be chaired by **Ciara Shanahan, AIEB Coordinator**.

Jacqueline Healy is the Public Sector Duty Manager with the Irish Human Rights and Equality Commission. She leads the Commission's work on supporting the effective implementation of the Public Sector Equality and Human Rights Duty within public bodies in Ireland. Before joining the Commission in 2017, Jacqueline worked for many years in the non-governmental sector with national organisations focused on gender equality, migration, anti-racism and interculturalism.

Ann Irwin and Rachel Doyle are the joint National Coordinators of Community Work Ireland. They designed and delivered a project on the role of civil society in the Public Sector Duty in Galway City.

Jamie Gorman is a lecturer in Community Work and Environmental Justice at Maynooth University and Convenor of the CWI Climate Justice Working Group. Jamie has a Masters in Community Work and a Doctor of Social Science. He previously worked with Galway City Community Network and is a former chairperson of Friends of the Earth.

Dr Brian Melaugh holds professional qualifications in community work and social work and is a lecturer in the Department of Applied Social Studies, Maynooth University. He has an interest in responses to drug use and the importance of the community voice in informing policy. Before taking up his academic position, he worked extensively in the area of drug practice and drug policy and was formerly the Director of the Ana Liffey Drug Project in Dublin and Chair of UISCE, an organisation that promotes the rights of drug users. Brian is on the Board of Merchants Quay Ireland and is a director of the North Inner City Local Drugs Taskforce.

Gary Broderick is Director of the SAOL project, an organisation with a track record in promoting the needs of female drug users and their children. He lectures in addiction on several programmes at Undergraduate and Postgraduate levels to students of community work, youth work and social work.

Anastasia Crickley is the Chairperson of AIEB, a member of the CWI Central Group and Convenor of the CWI Policy and Practice Working Group. She is a former chairperson of the UN Committee on the

Elimination of Racial Discrimination and is a current member of the National Anti-Racism Committee overseeing the development of the new National Action Plan on Racism. Anastasia has played leadership roles in the foundation and development of Pavee Point Traveller and the European Network Against Racism.

Reuben Hambakachere is the Equality, Diversity and Inclusion Officer with Cultúr, a community work organisation working with ethnic minorities in Meath.

A professionally qualified community worker, Reuben is a board member of Community Work Ireland, the Irish Refugee Council and a co-director of Our Table, a community driven non-profit project aiming to highlight the issues faced by people living in direct provision.
